ASSURANCE

Applications are invited for filling up of one post of Director General Aeronautical Quality Assurance in the revised pay scale of Rs.67,000- (annual increment @ 3%) - 79,000 in the Directorate General of Aeronautical Quality Assurance (DGAQA). The Director General Aeronautical Quality Assurance shall be the Head of the Service and shall be responsible for the development of the Service to the best advantage of the Government.

Method of recruitment

Deputation (ISTC).

Field of selection

Officers of the Central/ State/ UTs Governments/ Universities/ Recognised Research Institutions/ Public Sector Undertakings/ Semi-Govt/ Statutory or Autonomous Organisations including DRDO, Air Force, HAL, NAL, CEMILAC, ADA & DGCA

- (a) (i) Holding analogous post on regular basis in the parent cadre/department;
- or
- (ii) With three years service in the grade rendered after appointment thereto on regular basis in PB-4 i.e. Rs.37400-67000 plus Grade Pay Rs.10000 (corresponding to pre-revised scale of pay of Rs.18400-22400) or equivalent in the parent cadre / department; and

(b) possessing the following Educational Qualifications and experience:-
Essential

- (i) Master's Degree in Science or Degree in Engineering / Technology or Metallurgy from a recognized University or equivalent.
- (ii) 18 years service in Group 'A' posts or equivalent out of which 15 years actual experience in Production, Development or Quality Assurance of Aircraft and Aircraft accessories.

Desirable

- (i) Doctorate Degree (Ph.D) in Science or Master's Degree in Engineering / Technology or Metallurgy.
- (ii) Experience in Aeronautical Engineering.

Note 1 : Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organisation/department of the Central Govt. shall ordinarily not to exceed four years. The maximum age limit for appointment by deputation (ISTC) shall be not exceeding 56 years as on 01 December 2010.
